2.This petition has been filed by the petitioners seeking to condone the delay of 695 days in filing the above civil miscellaneous appeal.

3.This Court by order dated 20.11.2018 condoned the said delay subject to payment of cost of Rs.2,000/- to the Chief Justice Relief



fund within a period of one week from the date of receipt of a copy of that order. Subsequently, on the request made on the side of the petitioners, the time was extended till 18.12.2018, vide order dated 11.12.2018.

4.As per the said order, the petitioners have paid a sum of Rs.2,000/- to the Chief Justice Relief Fund and filed a memo to that effect. The same is recorded. Consequently, the petition is allowed.

5.Registry is directed to number the appeal if it is otherwise in order and list the same "for admission" forthwith.
