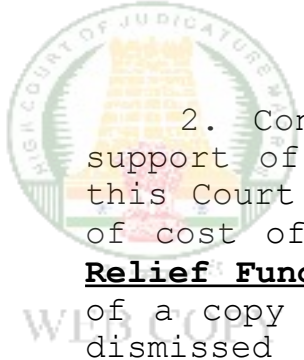
Petition praying that in the circumstances stated therein and in the affidavit filed therewith the High Court may be pleased to condone the delay of 198 days in paying the deficit court fee of Rs.4,705/- in the above CMA SR No.9040 of 2018 and thus render justice.

PRAYER IN CMA(MD) No.SR.9040 of 2018:

To set aside the order of the Tribunal of Motor Accident Claims Tribunal cum I Additional District Court, Tuticorin made in M.C.O.P.No.115 of 2015 dated 04.10.2017.

ORDER : This petition coming on for orders upon perusing the petition and the affidavit filed in support thereof and upon hearing the arguments of Mr.C.JAWAHAR RAVINDRAN, Advocate for the petitioner, the court made the following order:-

This petition has been filed to condone the delay of 198 days in paying the deficit Court fee in respect of the above civil miscellaneous appeal in C.M.A. (MD) No.SR9040 of 2018.



2. Considering the reasons stated in the affidavit filed in support of the petition and also considering the length of delay, this Court is inclined to condone the delay, subject to the payment of cost of Rs.1000/- (Rupees One Thousand only) to "**Chief Justice Relief Fund**", within a period of one week from the date of receipt of a copy of this order, failing which, this petition shall stand dismissed automatically, without any further reference to this Court.

3. This petition is accordingly ordered. On showing proof of payment, Registry is directed to number the appeal, if the papers are otherwise in order and list the appeal for admission on 04.12.2018.
