On that date, the concerned Magistrate was on leave and the incharge Magistrate was at Vedachandur, which is 85 kms away and therefore, the petitioner could not comply with the condition of this Court order, dated 12.10.2018.

4. In view of the same, petitioner is granted 15 days time to execute the sureties, from the date of receipt of a copy of this order.
