ORDER : The Court Made the following order :-

The petitioner apprehending arrest at the hands of the respondent police for the offences punishable under Sections 323, 341 of IPC in connection with Non Bailable Warrant issued in C.C.No.11 of 2018 on the file of the Judicial Magistrate No.II, Kuzhithurai, Kanniyakumari District, seeks anticipatory bail.

The concerned Judicial Magistrate is directed to consider the same on the same day.



5. Accordingly, the Criminal Original Petition is disposed of.
