### ORDER

4. In view of the submissions made by the learned counsel for the petitioner and the learned Special Government Pleader, without going into the merits of the averments made in the writ petition, this Court is constrained to pass the following order:

The first respondent is directed to consider the representation of the petitioner, dated 13.06.2017 and pass appropriate orders, after affording an opportunity of hearing to the necessary parties, within a period of 6 weeks from the date of receipt of a copy of this order.

5. The writ petition is disposed of with the above directions. No costs.
