PRAYER: Writ Petition is filed under Article 226 of the Constitution of India praying for the issuance of a Writ of Certiorarified Mandamus, to call for the record of the first respondent in Na.Ka.91/53/2017 dated 08.08.2017 and quash the same and consequently direct the first respondent to restore petitioner's patta granted in A/18-5/9 0.021.0 sq.mtr., within the period stipulated by this Court.

ORDER

This writ petition has been filed challenging the order passed by the first respondent / Special Tahsildar granting patta in favour of the second respondent.

2.Earlier, this Court ordered notice, and also granted on order of interim stay. Now, the respondents filed petitions for vacating the interim stay. By consent of both parties, the main writ petition is taken up for final hearing, today.

3.Admittedly, against the order passed by the first respondent / Special Tahsildar, an appeal is provided before the



Revenue Divisional Officer, thereafter, a revision is also provided before the District Revenue Officer. Without availing such remedies, the petitioner cannot file this writ petition, challenging the order passed by the Special Tahsildar. Hence, this writ petition is not maintainable.
