Prayer: Writ Petition - filed under Article 226 of the Constitution of India, to issue a Writ of Certiorarified Mandamus, calling for the records relating to the impugned order passed by the third respondent dated 10.08.2018 in Na.Ka.Aa2/1113/2018 and quash the same and consequently direct the respondents to include the petitioner's name in the joint patta instead of Ramasubbammal in S.No.136/1, 137/1, 137/2, 137/3, 304/3F2, 406/4 in K.Chidamparapuram Village, and S.No.127/3B, 172/2 in Ottanpatti Village, Thoothukudi District and consider the petitioner's representation dated 26.02.2018 within a stipulated time in accordance with law.

ORDER
