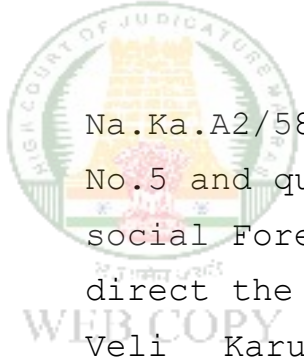

Prayer: Petition filed under Article 226 of the Constitution of India, praying for the issuance of a writ of Certiorarified mandamus to call for the records pertaining to the impugned final tender order in No.Ka-A2/582/2017 dated 05.04.2017 on the file of the Respondent No.5 and the consequential extension order in



Na.Ka.A2/582/2017 dated 26.07.2017 on the file of the Respondent No.5 and quash the same as illegal to the extent of inclusion of the social Forest Land in an extent of 25.32 Hectors and consequently to direct the Respondents No.1 to 3 to auction uprooting and cutting of Veli Karuveta trees in the social forest namely 1983/89 Thiruppuvanam Bit-2 (5.00 Hectares) and 1980/92 (5.72 Hectares) along with the items notified in the Forest Department General Tender Notification in Na.Ka.No.L/1188/2017, dated 26.09.2017 on the file of the respondent No.3 within the time stipulated by this Court.

ORDER

(Order of the Court was made by C.T.SELVAM, J.)

The learned counsel for the seventh respondent submits that the petitioner having participated in the auction pursuant to a notification, chose to challenge the same as Public Interest Litigation in W.P.(MD)No.4068 of 2017, which was dismissed by this Court, on 09.03.2017, informing the same to be a frivolous writ petition. The learned counsel submits that without making mention of the earlier writ petition, the petitioner moved this present writ petition seeking to challenge the work order issued to the seventh respondent.



2. Given the above position, this Court does not consider it appropriate to entertain this writ petition and accordingly, this Writ Petition shall stand dismissed. No costs. Consequently, connected Miscellaneous Petitions are closed.
