2.The learned counsel for the petitioner submitted that as per the second petitioner's name found in the F.I.R and all his documents, he is called as Sundar Raj. Since the second petitioner's name has been wrongly mentioned in the petition filed by the petitioner as Balan @ Balakrishnan, he could not able to execute the sureties before the concerned Court.
