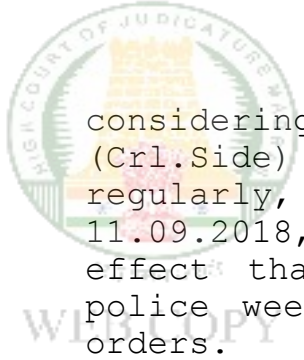
This Petition has been filed to relax the condition imposed in Crl.O.P. (MD) No.15990 of 2018, dated 11.09.2018.
