2.Heard the learned counsel for the petitioner and the learned Additional Public Prosecutor for the respondent.

3.It is seen that, there was a delay of 24 days in executing the sureties and surrender before the Trial Court, by the petitioner.

4.Considering the facts and circumstances of the case, this petition is ordered on condition that the petitioner shall deposit a sum of Rs.1000/- (Rupees one thousand only) to the credit of the Hon'ble Chief Justice Relief Fund and on such deposit, the time for surrender and to execute the sureties is extended by two weeks from the date of receipt of a copy of this order.
