The petitioner has filed this petition seeking production of his wife and to set her at liberty.

2.The matter stands posted today after both the petitioner and detainee were permitted to meet each other and have a talk. We once again permitted the petitioner to meet and have a talk with the detainee in our chambers. When the matter was called thereafter, the detainee was strong in her original stand of not inclined to join the petitioner. She is insisting upon cancellation of marriage certificate. The petitioner has informed that he would cooperate for the aforesaid process.
