Prayer:- Civil Miscellaneous Appeal preferred against the judgment and decree of the SUB JUDGE MACT TIRUCHIRAPPALLI, dated 19/04/2010 made in MCOP.728/2003

(3) That on such deposit being made, the claimants be and are hereby permitted to withdraw that award amount together with accrued interest on filing necessary application before the Tribunal.

(4) That there be no order as to costs in this Civil Miscellaneous Appeal.
