PETITION FOR ANTICIPATORY BAIL Under Sec. 438 Cr.P.C.

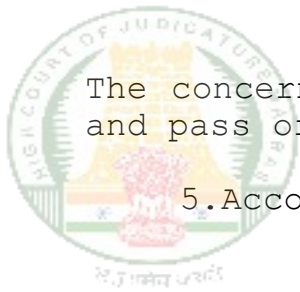
ORDER : The Court Made the following order :-

The petitioners apprehend arrest at the hands of the respondent police in C.C.No.61 of 2010 on the file of the learned Judicial Magistrate, No.II, Kuzhithurai, for the offences punishable under Sections 452, 294(b) 324, 427 and 506 (ii) I.P.C, seek anticipatory bail.

2.The petitioners were absent during the trial in C.C.No.61 of 2010 on the file of the learned Judicial Magistrate, No.II, Kuzhithurai, Therefore, Non-Bailable Warrant came to be issued on 05.03.2018.
