Prayer : Writ Petition filed under Article 226 of the Constitution of India to issue a Writ of Mandamus, directing the respondents to pay the petitioner's Rs.10,12,666/- towards Gratuity, Rs.4,26,360/- towards encashment of 240 days of earned leaves and 15 medical leaves, Rs.50,000/- towards Social Security Scheme Benefit, Rs.4,360/- towards refundable deposits, together with 18% interest per annum, along with interest amounts towards the delay periods from 31.05.2017 to 07.06.2017 from 31.05.2017 to 07.07.2017 and also from 31.05.2017 to 18.08.2017 in paying EPF Employee's Contribution amount in parts as Rs.1,80,000/-, Rs.1,80,000/- and Rs.1,80,676/- respectively, at the rate of 18% interest per annum, within a time frame that may be fixed by this Court.
