ORDER : The Court Made the following order :-

The petitioners, who apprehend arrest at the hands of the respondent police in C.C.No.24 of 2017 on the file of the learned Judicial Magistrate No.II, Kuzhithurai, for the offences punishable under Sections 147, 148, 341, 294(b), 323 and 506(ii) I.P.C, seek anticipatory bail.

2.The petitioners were absent during the trial in C.C.No.24 of 2017 on the file of the learned Judicial Magistrate No.II, Kuzhithurai. Therefore, Non-Bailable Warrant came to be issued on 12.10.2017.

The concerned Magistrate is directed to consider the same on merits and pass orders on the same day.



5. Accordingly, the Criminal Original Petition is disposed of.
