2.The learned Government Advocate (Crl.Side) appearing for the State submits that investigation is over and final report has been filed. But, it is yet to be taken on file.

3.In this circumstance, this Court is of the view that there is no need to cancel the anticipatory bail. Further, if the petitioner is facing any threat, it is open to the petitioner to move the trial Court for cancellation of the order granting relief to the accused persons.



4. With this observation and liberty granted to the petitioner, this criminal miscellaneous petition is dismissed.
