2. In view of the endorsement made, the Writ Petition is dismissed as withdrawn. No Costs.

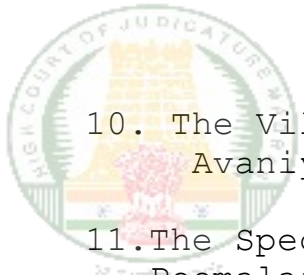
