PRAYER: Writ Petition is filed under Article 226 of Constitution of India for issuance of writ of Mandamus directing the 2nd respondent to issue certificate U/s 8 of Payment of Gratuity act to the 1st respondent to recover the gratuity amount of Rs.28,246/- together with interest at the rate of 10% p.a. from 01.10.2013 as ordered by the 2nd respondent in his order, dated 20.06.2016 in P.G.No. 31/2016 from the 3rd respondent and further directing the 2nd respondent to recover such amount from the 3rd respondent within a period of time. As may be fixed by this Court.
