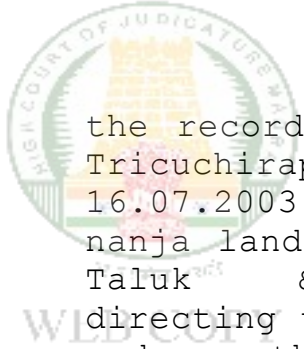

the records of the fourth respondent the Zonal Deputy Tahsildar, Tiruchirappalli, relating to Patta Pass Book No.56596 dated 16.07.2003 in regard to S.No.93/4 of an extent of 0.65.5 Ares of nanja land situate in Tharanallur Village of Tiruchirappalli East Taluk & Tiruchirappalli District and quash and consequently directing the respondents 1 to 4 to enquire into the manipulations and unauthorized corrections of revenue accounts in regard to S.No.93/4 of an extent of 0.65.5 Ares of nanja land situate in Tharanallur Village of Tiruchirappalli East Taluk & Tiruchirappalli District at the instance of respondents 7 to 9 and to take suitable corrective action and to restore the said property to the patta Bass Book No.525286 in the name of the petitioner society.

ORDER

Heard the learned counsel on either side.

2.There is a serious dispute between the petitioner and the seventh respondent and the others. The case of the petitioner is that the documents in the custody of the District Administration have been tampered with. In this regard, the petitioners has lodged a complaint on 23.11.2017.

3.The first respondent is directed to enquire into the said complaint and if the allegations are made out take appropriate action in accordance with law. The first respondent shall of course hear the affected parties before passing any final order or taking any action. The entire exercise shall be completed within a period of twelve weeks from the date of receipt of a copy of this order. It is made clear that this Court has not expressed any opinion on the merits of the matter.

4.The Writ Petition is disposed of accordingly. No costs. Consequently, the connected miscellaneous petitions are closed.
