ORDER : The Court Made the following order :-

The petitioner, who apprehends arrest at the hands of the respondent police in C.C.No.72 of 2016 on the file of the learned Judicial Magistrate, Vaiyampatti for the offences punishable under Sections 279 and 304(a) I.P.C, seeks anticipatory bail.

2.The petitioner was absent during the trial in C.C.No.72 of 2016 on the file of the learned Judicial Magistrate, Vaiyampatti. Therefore, Non-Bailable Warrant came to be issued on 18.07.2016.

3.The learned counsel appearing for the petitioner undertakes that the petitioner shall appear before the Court below regularly on all future hearing dates without fail.

Considering the undertaking given by the petitioner, the petitioner is directed to appear before the learned Judicial Magistrate, Vaiyampatti within a period of two weeks from today and to file a petition to recall the NBW issued against him. The concerned Magistrate is directed to consider the same on merits and pass orders on the same day.
