To pass an order of injunction restraining the respondents from demolishing the compound wall or the superstructure in Door No.1/154, Old Survey No.45/1 Part, new Natham Survey No.203/13, Koothoor Village presently in Manachanallur Taluk earlier in Lalgudi



Taluk, Tiruchirappalli District pending disposal of the writ petition.
