Such a bald averment does not carry any conviction. It only shows that how the Court's indulgence in treating restoration petitions with far too liberal approach is taken for granted Therefore, this Court is not satisfied with the



explanation offered by the petitioner. Hence, the restoration petition is dismissed.
