ORDER : The Court Made the following order :-

The petitioner, who apprehends arrest at the hands of the respondent police in C.C.No.49 of 2014 on the file of the learned Judicial Magistrate No.II, Kuzhithurai for the offences punishable under Section 379 I.P.C, seeks anticipatory bail.

2.The petitioner was absent during the trial in C.C.No.49 of 2014 on the file of the learned Judicial Magistrate No.II, Kuzhithurai. Therefore, Non-Bailable Warrant came to be issued on 26.12.2017.

3.The learned counsel appearing for the petitioner undertakes that the petitioner shall appear before the Court below regularly on all future hearing dates without fail.

Considering the undertaking given by the petitioner, the petitioner is directed to appear before the learned Judicial Magistrate No.II, Kuzhithurai within a period of two weeks from today and to file a petition to recall the NBW issued against him. The concerned Magistrate is directed to consider the same on merits and pass orders on the same day.



5. Accordingly, the Criminal Original Petition is disposed of.
