ORDER : The Court Made the following order :-

The petitioner, who apprehends arrest at the hands of the respondent police in S.C.No.86 of 2005 on the file of the learned District Sessions Judge, Dindigul for the offences punishable under Sections 147, 148, 341, 342, 307 @ 302 I.P.C r/w Section 149 I.P.C. seeks anticipatory bail.

2.The petitioner was absent during the trial in S.C.No.86 of 2005 on the file of the learned District Sessions Judge, Dindigul. Therefore, Non-Bailable Warrant came to be issued on 03.04.2013.

The concerned Judge is directed to consider the same on merits and pass orders on the same day.



5. Accordingly, the Criminal Original Petition is disposed of.
