ORDER

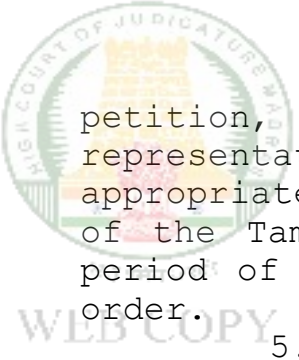
The petitioner has filed this writ petition seeking for a direction to the second respondent to consider his application for giving electricity service connection.

3.The petitioner claims to be in possession of poramboke land measuring 5 cents and he has put up a house therein. He has also filed an application on 03.05.2017 seeking electricity service connection before the second respondent. Since no order has been passed by the second respondent, the present writ petition has been filed.
