Prayer : Writ Petition is filed under Article 226 of the Constitution of India, to issue a Writ of Mandamus, to direct the respondents to re-fix petitioner pay as 5200-20200+Grade pay 2400 from 5200-20200+Grade pay 2000 with effect from 01.06.2006 as per the G.O.Ms.No.63 dated 26.02.2011 within the time limit fixed by this Court based on the petitioner representation dated 10.03.2015.

ORDER

Heard the learned counsel on either side.

2.The petitioner was working as a Record Clerk in an aided school. He went on voluntary retirement on 24.12.2006. The petitioner now seeks re-fixation of pay in terms of G.O.Ms.No.63, Finance (Salary Department) dated 26.02.2011.

3.This Court went through the contents of the said Government Order. By applying the said Government Order, Grade Pay was enhanced from 2000 to 2400 for certain category of posts.



Unfortunately, the post of Record Clerk was not referred to in the said Government Order. Since the post of Record Clerk was not granted benefit in terms of the said Government Order, the petitioner cannot ask for any relief. The petitioner has not made out a case for granting relief.

4. There is no merit in the writ petition, it stands dismissed.
