**ORDER**

The petitioner is the pensioner. He seeks the benefits under G.O.Ms.No.363, dated 23.08.2013. In fact, the respondents have already implemented the said G.O. In this case, the pension payable to the writ petitioner has also been revised by proceeding dated 13.02.2015. However, the learned counsel for the petitioner would submit that the arrears are yet to be paid.

2.The stand of the first respondent is that the said amount has been disbursed.

3.Be that as it may, it is seen that no order has been passed on the petitioner's representation dated 27.07.2016. Therefore, the first respondent is directed to pass orders on the said representation dated 27.07.2016, on merits and in accordance with law, within a period of eight weeks from the date of receipt of a copy of this order.

4.The writ petition is disposed of accordingly. No costs.
