ORDER : The Court Made the following order :-

The petitioner apprehends arrest at the hands of the respondent police in C.C.No.137 of 2016 on the file of the learned Judicial Magistrate Court No.2, Kuzhithurai for the offences punishable under Section 323 I.P.C and Section 4 of Women Harassment Act, seeks anticipatory bail.

2.The petitioner was absent during the trial in C.C.No.137 of 2016 on the file of the learned Judicial Magistrate Court No.2, Kuzhithurai. Therefore, Non-Bailable Warrant came to be issued on 24.01.2018.
