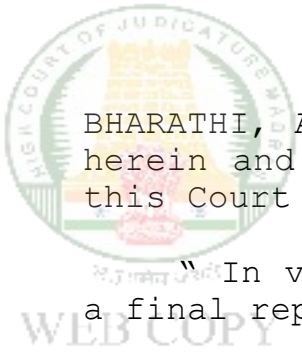
Prayer in CRL MP(MD) No.7314 of 2018:
