This petition is filed to extend the time limit of the petitioners' surrender and execute sureties in Crl.M.P(MD).No. 6655 of 2018 in Crl.O.P(MD)No.13298 of 2018, dated 24.08.2018.

2.Heard the learned counsel for the petitioners and the learned Additional Public Prosecutor appearing for the respondent.

3.It is seen that there was some delay to execute the sureties and surrender before the Trial Court by the petitioners.

4.Considering the facts and circumstances of the case, this petition is ordered on condition that the petitioners shall deposit a sum of Rs.1,000 (Rupees one thousand only) each, in total Rs.2,000/- (Rupees two thousand only) to the credit of the Hon'ble Chief Justice Relief Fund and on such deposit, the time for surrender and to execute the sureties is extended by two weeks from



the date of receipt of a copy of this order.

5.The petitioners are directed to produce the receipt of deposited amount at the time of executing the sureties.

6.Accordingly, this Criminal Miscellaneous Petition is allowed.
