For Respondents : Ms. Porkodikarnan

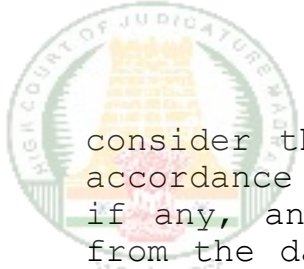
O R D E R

3. The learned counsel for the petitioner submitted that it would suffice if the representation of the petitioner dated 25.06.2018 is disposed of, in accordance with law, within a time frame to be fixed by this Court.

4. In view of the limited scope of the prayer, without going into the merits of the matter, the respondents are directed to



consider the representation of the petitioner, dated 25.06.2018 in accordance with law, after giving notice to the interested parties, if any, and pass appropriate orders within a period of four weeks from the date of receipt of a copy of this order, preferably on or before 10.11.2018, if there are no legal impediments.
