PRAYER IN CMA(MD)No.SR29763 of 2018:

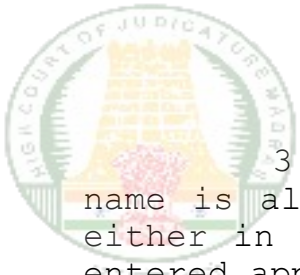
