ORDER : The Court Made the following order :-

The petitioner apprehends arrest at the hands of the respondent police, they filed a charge sheet in S.T.C.No.215 of 2016 on the file of the learned Judicial Magistrate No.II, Kuzhithurai for the offences punishable under Sections 341, 342, 294(b), 323, 506(i) I.P.C, seeks anticipatory bail.

The concerned Magistrate is directed to consider the same on merits and pass orders on the same day.



5. Accordingly, the Criminal Original Petition is disposed of.
