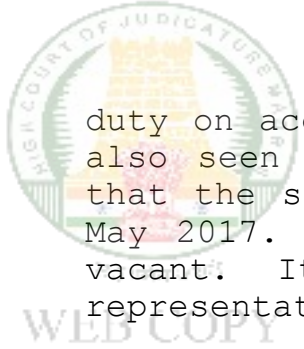

Heard the learned counsel on either side.

2.The petitioner seeks issuance of a writ of Mandamus for directing the respondents 2 and 3 to conduct interview for filling up the post of Office Assistant in the third respondent Union. The Writ Petition was filed on 16.08.2016.

3.The learned counsel for the third respondent/Union would point out that the interview was actually conducted on 04.08.2016 and the petitioner had also participated in that interview. He produced a copy of the proceedings also. Therefore, there is no merit in the Writ Petition and the same liable to be dismissed.
