Writ Petition is filed under Article 226 of the Constitution of India, praying this Court To issue a WRIT OF CERTIORARIFIED MANDAMUS, to call for the records in pursuant to the impugned order passed by the 3rd Respondent in Letter No.0050/Ni.Ya.1/TNSTC/Thi.Li./11-4 dated 21-01-2011 and Quash the same and consequently direct the Respondents to provide Employment to the petitioner on compassionate grounds based on the G.O.Ms.No.10 Labour and Employment Department dated 13-02-2009 and Educational



Qualification.
