3.According to the Petitioner they made a representation/letter dated 6.9.2018 and that there are no surplus teachers in R.C.Diocese Schools, Tirunelveli District for the academic year 2017-2018.

4.According to the respondents, they have already communicated to the Petitioner that there are surplus posts in the Petitioner/Schools. Therefore, the Petitioner will have to redeploy the teachers to some other schools, failing which, it is open to the respondents to stop aid to the Petitioner/Schools.

5.In view of the above, the respondent concerned is directed to consider the representation/letter, dated 6.9.2018 submitted by the Petitioner based on the above observation and to pass appropriate orders on the same in accordance with the rules, within a period of two months from the date of receipt of a copy of this order.

6.With the above direction, the Writ Petition is disposed of. No costs.
