ORDER : The Court Made the following order :-

The petitioner, who apprehends arrest at the hands of the respondent police in S.C.No.59 of 2006 on the file of the learned Additional District and Sessions Court (Mahila) at Nagercoil for the offences punishable under Sections 341, 366 and 506(ii) I.P.C. seeks anticipatory bail.

2.The petitioner was absent during the trial in S.C.No.59 of 2006 on the file of the learned Additional District and Sessions Court (Mahila) at Nagercoil. Therefore, Non-Bailable Warrant came to be issued 27.04.2013.

The concerned Judge is directed to consider the same on merits and



pass orders on the same day.

5. Accordingly, the Criminal Original Petition is disposed of.
