This petition is filed to extend the time limit of the petitioner's surrender and execute sureties in Crl.O.P(MD)No.14492 of 2018, dated 14.08.2018.

2.Heard the learned counsel for the petitioner and the learned Additional Public Prosecutor appearing for the respondent.

3.It is seen that there was a delay of 15 days to execute the sureties and surrender before the Trial Court by the petitioner.

4.Considering the facts and circumstances of the case, this petition is ordered on condition that the petitioner shall deposit a sum of Rs.1,000 (Rupees one thousand only) to the credit of the Hon'ble Chief Justice Relief Fund and on such deposit, the time for surrender and to execute the sureties is extended by two weeks from the date of receipt of a copy of this order.
