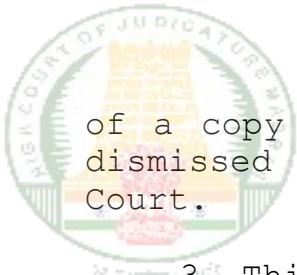
PRAYER IN CMA.SR39387 of 2018:
