2.Heard the learned counsel for the petitioners and the learned Additional Public Prosecutor appearing for the respondent.

3.It is seen that there was a delay of morethan 10 days to execute the sureties and surrender before the Trial Court by the petitioner.

4.Considering the facts and circumstances of the case, this petition is ordered on condition that the each of petitioners shall deposit a sum of Rs.1,000 (Rupees One thousand only) to the credit



of the Hon'ble Chief Justice Relief Fund and on such deposit, the time for surrender and to execute the sureties is extended by two weeks from the date of receipt of a copy of this order.

5. The petitioners are directed to produce the receipt of deposited amount at the time of executing the sureties.

6. Accordingly, this Criminal Miscellaneous Petition is allowed.
