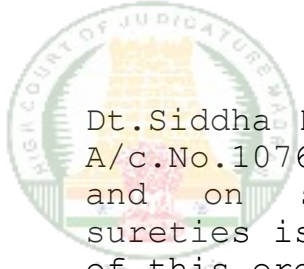

This petition is filed to extend the time limit of the petitioner's surrender and execute sureties in Crl.O.P(MD)No.11341 of 2018, dated 06.07.2018.

2.Heard the learned counsel for the petitioner and the learned Additional Public Prosecutor appearing for the respondent.

3.It is seen that there was a delay of more than one month to execute the sureties and surrender before the Trial Court by the petitioner.

4.Considering the facts and circumstances of the case, this petition is ordered on condition that the petitioner shall deposit a sum of Rs.1,000 (Rupees one thousand only) to the credit of
