ORDER

This petition has been to quash the criminal proceedings in Crime No.276 of 2016 on the file of the first respondent in C.C.No.91 of 2017 on the file of the learned Judicial Magistrate, Devakottai.

2.Today, when the matter was taken up, the petitioners, the 2nd respondent and the learned counsel appearing for the petitioners are present and they have filed a memo of compromise stating that they have compromised the matter and the *de facto* complainant do not want to pursue the matter against the petitioners and she has no objection to quash the proceedings against the petitioners.
