COMMON ORDER

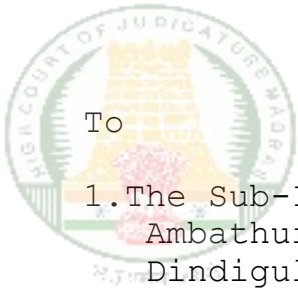
