### **O R D E R**

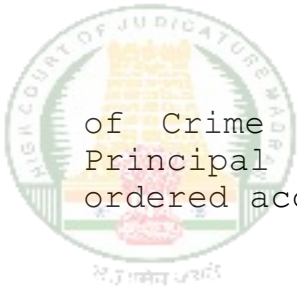
