It is also clarified that the petitioners shall serve the advance notice to the defacto complainant in due compliance of Section 15 (A) of the SC/ST Act. The notice shall be served on the Special Public Prosecutor of the concerned Court enclosing the additional copy to be served on the defacto complainant three days prior to the date of intended surrender. The intended date of surrender shall also be mentioned in the notice.

2.Time is extended further for a period of two weeks from the date of receipt of a copy of this order.

3.This petition is allowed accordingly.
