The petitioner seeks for a Writ of Mandamus, directing the respondents to regularize the petitioner's service in the post of B.T. 4.In view of the limited scope of the prayer, without going into the merits of the matter, the respondents are directed to consider the representation of the petitioner dated 18.01.2018 and pass appropriate orders thereon in accordance with law, preferably within a period of three months from the date of receipt of a copy of this order, if there are no legal impediments.

5.With the above direction, the Writ Petition stands disposed of. No costs.
