PETITION FOR ANTICIPATORY BAIL Under Sec. 438 Cr.P.C.

ORDER : The Court Made the following order :-

The petitioner apprehends arrest at the hands of the respondent police in S.C.No.45 of 2012, on the file of the learned Chief Judicial Magistrate, Kumbakonam, for the offence punishable under Sections 307 of IPC r/w. 4(1)(aaa) of TNP Act (Transport) r/w.132 r/w.177 of M.V.Act, seeks anticipatory bail.

2.The petitioner was absent during the trial in S.C.No.45 of 2012, on the file of the learned Chief Judicial Magistrate, Kumbakonam. Therefore, Non-Bailable Warrant came to be issued on 17.07.2017.

3.The learned counsel appearing for the petitioner undertakes that the petitioner shall appear before the Court below regularly on all future hearing dates without fail.

4. Considering the undertaking given by the petitioner, the petitioner is directed to appear before the learned Chief Judicial Magistrate, Kumbakonam, within a period of two weeks from the date of receipt of copy of this order and to file a petition to recall the NBW issued against him. The concerned Magistrate is directed to consider the same on merits and pass orders on the same day.



5. Accordingly, the Criminal Original Petition is disposed of.
