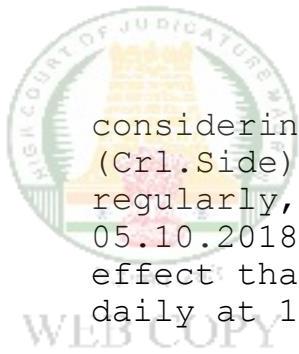
This Petition has been filed to relax the condition imposed in Crl.O.P.(MD)No.17803 of 2018, dated 05.10.2018.
