ORDER : The Court Made the following order :-

The petitioner apprehends arrest at the hands of the respondent police in S.C.No.350 of 2013 on the file of the III Additional Sub Court, Madurai, (CAMP) Usilampatti, Madurai District, for the offences punishable under Section 324 IPC and Section 3 (1) of TNPPDL Act, seeks anticipatory bail.

The concerned Magistrate is directed to consider the same on merits and pass orders on the same day.
